Participation Details:

1. **Type of Vehicle (for the Trunk or Treat setup):**

Example: Car, Truck, SUV, Van, etc.

2. **Booth:** 12x12 space provided

- If you need more than 12 X 12 space for a vehicle or booth you must make prior arrangements This is strictly enforced.
- **DO NOT** assume that we know your needs. Bring your own shade, tables, easels, generators etc. **AS THESE ITEMS WILL NOT BE PROVIDED.** (No electricity provided)
- Please indicate any special needs you may have. We will do our best to accommodate your request.
- Upon arrival to Barker Park, please check in at the WRPD office to get your location.

3. The rules of the parks are no alcohol, no smoking, no driving on parks. Please observe

Event Guidelines: In order for all parties involved to have specific guidelines, and in order for Wasco Recreation and Park District. to have a record of the following agreement, the following terms are agreed to by the Wasco Recreation and Parks District and :

1. **Candy and Giveaway Items:**
 - All participants are required to provide their own candy or giveaway items.
 - All items must be individually wrapped and commercially packaged. No homemade items are allowed.
 - We recommend preparing for 1500 participants.
2. **Vehicle / Booth Setup:**
 - All vehicles/booths should arrive by 5:15 p.m. to be ready before the event starts.
 - Please ensure that your vehicle/booth is decorated in a family-friendly and non-scary theme. (WRPD Office staff will be available from 4 p.m-6 p.m. to answer any questions and assist you with your dedicated space)
 - No explicit or overly frightening decorations will be allowed.
3. **Clean-Up:**
 - Participants are responsible for maintaining a clean area around their vehicle/booth and cleaning up after the event.
4. **Safety:**
 - For the safety of all children, we require that no smoking, alcohol, or pets are present during the event.
 - The Applicant agrees to operate a vehicle/booth at the Wasco Recreation and Park District 2024 Halloween Trunk or Treat
 - Applicant must follow and agree to all the rules imposed upon you from this agreement.
5. I/We the applicant(s) understand that the Wasco Recreation and Park District assumes no responsibility for the safety of my volunteers or the contents of our display, before during or after the 2024 Halloween Trunk or Treat.
6. I/We the applicant(s) understand that the Wasco Recreation and Parks District agrees to provide a 12 X 12 area for my display.
7. I/We the applicant(s) understand the electricity and shade for my booth are my responsibility.
8. I/We the applicant(s) understand that the electricity will not be provided at anytime, day or night,
